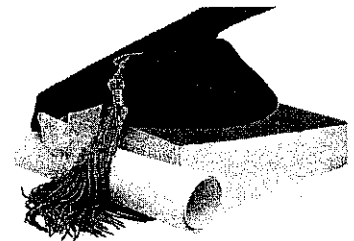

\$ 1,000 COLLEGE TUITION SCHOLARSHIPS

The Executive Board of Teamsters Joint Council No. 41 is proud to announce the award of One Thousand Dollar (\$1,000) College Tuition Scholarships to outstanding high school seniors from families of members of Local Unions affiliated with the Joint Council. Each affiliated Local Union will receive a \$1,000 tuition scholarship to be awarded to a deserving high school senior of an active, retired, disabled/deceased or laid-off Teamster member from that Local Union. Each tuition scholarship awarded will be paid to the two-year or four-year college or university of the student's choice, directly by Joint Council 41 in the name of the affiliated Local Union. All scholarship award decisions will be made by the Local Union Executive Board on a nondiscriminatory basis, according to written guidelines that are summarized below.

As this program is extremely competitive, all applications must comply with the following eligibility and application criteria. Each applicant must:

1. be the son or daughter of an active, retired, disabled/deceased or laid-off Teamster member who has or had at least twelve months of consecutive membership in good standing in the Teamsters Union affiliated with Joint Council No. 41;
2. be in his/her last year of high school and may not apply if he/she has already graduated from high school;
3. be in the top 15% of his/her high school class,
4. plan to submit excellent SAT or ACT scores for evaluation;
5. plan to attend a regionally accredited college or university. Those who plan to attend non-academic or certificate programs may not apply.
